REPORTS & RECOMMENDATIONS OF MUNICIPAL OFFICERS**CAO/Clerk – Maitland Valley Snowmobile Club – Henfryn**

CAO/Clerk Brad Knight reviewed his report to Council regarding a request from the Maitland Valley Snowmobile Club to use part of the former CN Railway property at Henfryn (Lot 35, Concession 9, Grey Ward). Council were advised the former CN line was acquired by Grey Township in 1994 and while most of the line was sold off to abutting property owners, the land in Henfryn was retained as it provided an outlet for the trail that North Perth was retaining and it was noted that Henfryn residents use it as a walking trail. The Maitland Valley Snowmobile Club have provided a Memorandum of Understanding for snowmobile trail land use permission commencing December 2nd, 2020 and ending November 30th, 2025. The CAO noted that the snowmobile club had obtained similar permission from the Municipality of North Perth to use the former railway lands in North Perth as part of their snowmobile trail system.

CAO/Clerk Brad Knight reviewed his report to Council concerning a grant application to Investing in Canada Infrastructure Program (ICIP) – Covid Stream. COUNCIL REPORTS

Welcome to Howick Signage

Councillor Lowe noted that he had previously questioned the location of Howick Township entrance signage on the Grey side of Highway 86 and inquired why it hadn't been removed. Public Works Coordinator Barry Mills advised the Township of Howick has been contacted in regards to this matter and the sign will be moved to the Howick side of the road shortly.

Street Lights

Councillor Lowe expressed concern that street lights that were not working properly were not being repaired in a timely manner by the contractor that had been hired by the Municipality. The Public Works Coordinator advised that since the conversion to LED lighting there is not the same level of maintenance required and the contractor works in the maintenance requests as time permits – he advised that he was aware of the locations that Councillor Lowe spoke of and will raise the issue with the contractor.

Redevelopment of Downtown Properties – Brussels

Councillor Lowe expressed concerns with the redevelopment of numerous properties located in downtown Brussels, specifically the properties owned by Bryan Morton and questioned if proper permits were being obtained and if locates were being obtained.

The CAO advised that while Mr. Morton had taken out a demolition permit, he did not disclose his plans at that time to renovate/refurbish areas at the rear of his commercial properties into suites for use by individuals attending events at his banquet barn. He further noted that he was aware that Mr. Morton had hit some utilities during his demolition work, noting municipal staff were also frustrated by the lack of proper planning and documentation and that the CBO has issued a Stop Work Order on the property until proper redevelopment plans were submitted, but noted that some of the demolition work had to be completed to close in areas for the winter months. The CAO noted that Mr. Morton has been advised that he should assemble a development team for the project, including an architect. He further noted that that Mr. Morton had requested a meeting with staff in early January to discuss his proposal.
